INSTRUCTIONS: Athletic Field/Court Permits are designed for groups who would like to reserve a field or court for exclusive use for an athletic activity. Park District of Oak Park does not allow the permitting of athletic spaces to individuals or organizations for privately run camps/programs/lessons for commercial purposes. Unless otherwise stated, permits include basic field/court prep work by Park District staff and do not include use of any equipment or lights. Applicants should complete and submit this form (via online, fax or in-person), non-refundable application fee (\$10 for Oak Park-based groups or \$25 for non-residents), and certificate of insurance listing the Park District of Oak Park as additionally insured (or \$100 deposit) for review at least 3 weeks prior to the date of your event. Incomplete applications will be denied. All applications must be approved by the Park District. Once approved, you will receive a copy of your approved permit application via e-mail. You can expect to receive a response regarding your application within 10 business days after it has been submitted. Athletic Field/Court Permits are only available to the public from April—October.
