Little did we know at the time that we were working with a citizen who would become a major resource to our staff and a dedicated volunteer to our organization. Dick intently followed and contributed to the development of the Dogs in Oak Park Plan while organizing the Friends of the Oak Park Dogs group. At the same time, he volunteered to analyze the data collected from the 2004 community attitude and interest survey and translate it into useful information that he generously shared with the administrative staff as well as the Park District Citizen Committee long before he became a member. Dick McKinlay's survey analysis has equipped the Park District to make informed decisions in the areas of program planning, park master plan development, facility operations and even in the area of communications and marketing. Dick was eventually tapped to serve on the PDCC in early 2007 and since then has followed the Taylor Park, Ridgeland Common and Mills Park planning processes as a PDCC representative. In 2008, when the Park District needed a champion to secure a Community Development Block Grant, Dick stepped up to the plate to put together a solid proposal. OAK PARK PUBLIC WORKS

The relationship between the Park District of Oak Park and the Village of Oak Park goes back nearly 90 years. Today's recognition of the Public Works Department of the Village of Oak Park is not meant to be a history lesson; it is to acknowledge the "above and beyond efforts" of the staffs of the Forestry Department, the Fleet Services Division, the Streets and Sanitation Department and the Street Lighting, Engineering, and Water and Sewer Departments.

The number of times the Public Works Department has provided their assistance to the Park District are countless. Here are just a few examples of why they are a valued partner in providing quality parks and recreation in Oak Park. The Village Engineering Division facilitated the Park District's access to Village-contracted rates for the replacement of water and sewer lines at Ridgeland Common and a service drive to the west of the Paul Hruby Ice Arena. A similar extension was made at Carroll Park allowing for the completion of a major park redevelopment project. In all, hundreds of thousands of dollars in labor and material were saved through cooperative efforts of the Engineering Division. The Water and Sewer Department Staff, the Forestry Staff and the Street Lighting Staff have answered numerous calls for help in loaning equipment and providing technical expertise. Fleet Service maintains Park District vehicles and addresses fleet problems with competence and professionalism to make sure vehicles are fixed efficiently and within the budget. Finally, we must thank the Streets and Sanitation Division who regularly assist the Park District with special cleanups and recycling efforts prior to and/or after special events.

It is our pleasure and privilege to acknowledge to our residents the

care, thoughtfulness, respect, dedication, and professionalism being manifested by the men and women of the Public Works Department of the Village of Oak Park. With this in mind, we proudly present Oak Park Public Works with the IPRA Community Service Award.
