III. ADMINISTRATION AND FINANCE COMMITTEE

- A. <u>2025 Committee & Board Meeting Calendar</u> Executive Director Arnold noted that dates have been proposed for the 2025 Committee and Board meetings. A. <u>947 Ridgeland Solar Project Bid</u> – Chris Lindgren informed the Board that the CIP includes work for a solar array on the new roof at 947 Ridgeland to offset a large position of the electric usage for the property. Staff went out to bid on September 27, 2024, and a pre-bid meeting is set for October 8, 2024. The bid will be held on October 15, 2024. A. <u>VOP IGA Regarding Discounted Memberships for Village Employees</u> – Executive Director Arnold noted that as part of the Village of Oak Park's Wellness Initiative, the Park District shall offer qualifying Village employees a discounted membership (at the resident rate) to the amenities available at the CRC. The Village shall supply to the Park District on a rolling basis the names of the qualifying employee that opts into the Initiative. The Discounted memberships shall be for a monthly "Individual Memberships". Payment of membership due to the Park District shall be the obligation of the Village on a monthly basis. The memberships would be effective December 2024 for Village employees. The agreement would expire on December 31, 2027. **This item will be brought before the Board on the Regular Agenda at the October Regular Board Meeting.**
